Personal data to be collected:

Name-surname, address, telephone number, email, ID card number, date of birth, photo, marital status, occupation, income

Processing purposes:

Processing period:

The Company will process personal data throughout the period of which the relevant agreement or business transaction between the Customer and the Company is still valid or active, and/or as required for the compliance of law or under the statute of limitations or for the establishment, compliance, exercise, or defense of legal claims. Upon expiration of the permitted period, the Company shall eradicate such data/document by an appropriate method.

Person to which personal data may be disclosed:

The Company may disclose the personal data to government agencies as being required by laws.

The Company may disclose the personal data for its legitimate interest in conducting business operations of the Company by taking into account the Visitors' fundamental rights, and as being required by the laws.

Where this happens, a clear notice will be provided, that gives the opportunity to opt out or opt in to such sharing as required by applicable data protection laws. Rights of the Data Subject

1. Withdraw any consent given to the Company (if any);
2. Access your personal data including to obtain copy of such personal data or to be informed the source of collection without your consent (if any);
3. Obtain from the Company or request the Company to transfer to other data controllers the personal data that can be transferred automatically;
4. Object the collection, use or disclose of your personal data;
5. Request the Company to delete, eradicate or make unidentifiable your personal data;
6. Request the Company to suspend the use of your personal data;
7. Request the Company to correct or update your personal data to avoid confusion
8. Make complain to the authority in case you consider the Company's action not in compliance with the Personal Data Protection Act B.E. 2562 (2019).

 2. Date of building: 12 November 2024, Time 10.00 a.m. - 12.00 p.m. (Bare space)
12 November 2024, Time 1.00 p.m. - 12.00 p.m. (Standard Booth)
Shows day: 13-15 November 2024, Time 9.00 a.m. - 6.00 p.m. (Business matching program)
Demolition day: 15 November 2024, Time 6.30 p.m. - 12.00 p.m.
 - *** **Remark** : Construction and additional decoration, if exceeding the designated time, exhibitors will be required to pay an additional fee of 3,000 baht per hour.
 - ** In the case of requesting a modification to the receipt by the exhibitor, the organizer requests a fee of **200** baht per receipt.
 3. To confirm participation in the exhibition and additional packages: Registration for the event and additional packages will be considered complete when the applicant has filled out the application form completely and adheres to the specified conditions.
 4. Assigning booth numbers or package numbers: The reservation process will follow a first-come, first-served basis, depending on the signing of the contract and payment in accordance with the terms and conditions.
 5. Cancellation Policy:
The organizer reserves the right to cancel the contract if the applicant fails to make full payment.
Once the applicant has registered for the event, if they request to cancel the participation contract, the organizer has the right to retain the full payment made.
The organizer reserves the right to make changes or cancel the event. In the event of cancellation, the organizer will refund the paid amount to the exhibitor without interest.
The organizer reserves the right to cancel the contract and terminate the booth in the event that the applicant fails to comply with the exhibition regulations or engages in any activity that disrupts the peaceful environment within the event. In such cases, the organizer has the right to retain the full payment made.
 6. Compliance with Exhibition Regulations:
Exhibitors must study and comply with the regulations in the Exhibition Manual for COVID-19 prevention measures (as attached). If there is any violation or failure to comply, the organizer reserves the right to suspend the sale of products or any activities of the exhibitor in order to improve the exhibition area.
 - Exhibitors must undergo screening processes, temperature checks, and QR code scanning before entering and exiting the exhibition area.
 - Exhibitors must wear the provided identification card at all times while in the exhibition area.
 - Exhibitors are not allowed to sell their booth space or additional packages to others. In case of any such occurrence, the organizer reserves the right to cancel the booth and additional packages.
 - Exhibitors must adhere to the specified opening and closing times of the exhibition. The organizer will not be held responsible for any damages incurred to the exhibitor's booth if the exhibitor fails to comply.
 - In the event of loss of merchandise within the booth, the organizer is not liable for any compensation for damages under any circumstances.
 - The exhibitor must hire security personnel to safeguard the assets within their booth.
 - The placement of products or activities must be within the designated area as stated in the contract.
